Moreover the paper grade is in compliance with the demands of the

regarding the migration of certain elements.

Thus the paper grades **AustroTop, AustroLiner 1, AustroLiner 2, AustroLiner 3, Austro-Fluting Plus, AustroFluting R** and **AustroWelle** according to the sample material submitted may be used safely in the field of food packaging. They may stand in direct contact with dry, non-fatty foodstuffs and such kind of foodstuffs which are peeled, shelled or washed before consumption and may also be used for secondary packaging. For dry, non-fatty foodstuffs with large surfaces, the migration of volatile and hydrophobic substances via the gas phase has to be considered particularly. This could be ensured by the use of an appropriate intermediate packaging.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
