

#### Visitor's Guide Safety Instructions

#### Welcome



Dear guest,

- All visitors call their contact person via our terminal in the entrance area. The contact person collects the visitor and fills out documents such as visitor badge, entry permit, if necessary.
- The driveway access to the factory is only permitted with a authorization.
- Access only with safety vest and safety shoes.
- Plant equipment may not be operated, modified or removed without permission.
- All injuries and accidents must be reported to the PIC immediately.
- We reserve the right to check vehicles and loads.
- During Standstill wear bump caps/helmets.

Safety shoes must be worn while working in the production hall, the workshop and the warehouses area.
